WHAT IS RHLS SECTION 3 BUSINESS CERTIFICATION?

The RHLS Section 3 Business Certification Program helps businesses that are owned by low-income people or that hire low-income people in Allegheny County to connect with contracting opportunities on federally-funded projects.



WHO IS ELIGIBLE FOR SECTION 3 BUSINESS CERTIFICATION?

Millions of dollars' worth of Section 3 covered contracts are awarded every year by the seven Section 3 recipient agencies in Allegheny County. The Section 3 Business Certification Program is designed to help eligible businesses take advantage of these contracting opportunities. The following is a partial list of the kinds of businesses that could benefit from Section 3 certification:

WHAT IS HUD SECTION 3?

Section 3 of the Housing and Urban Development Act of 1968 is a federal law that requires agencies, developers and contractors that receive funding from the U.S. Department of Housing and Urban Development (HUD) to provide training, hiring and contracting opportunities to low-income residents and businesses of the area where the HUD-funded project is located, "to the greatest extent feasible".

IS MY BUSINESS ELIGIBLE?

Your business is eligible for Section 3 Business Certification if it meets any <u>ONE</u> of the following criteria:

1. 51% or more of the business is owned by individuals whose household income is no greater than 80% of the HUD Area Median Income (AMI).

2. 30% or more of the business' full time, permanent employees had household incomes no greater than 80% of AMI as of the initial date of hire.

3. The business awards 25% or more of the dollar value of the business' contract to business concerns that meet the qualifications set forth in (1) or (2) above.
